1st Deposit: A deposit of 10% of Total Tuition is due upon signing the Enrollment Contract.

2nd Deposit: An additional deposit of 10% of the Total Tuition is due in April 2024.

Payment Option A: Payment is due in June 2024.

Payment Option B: Payment is due in two equal payments in June 2024 and November 2024. This option includes a 3% service fee, reflected in the numbers above.

Payment Option C: Payment is due monthly starting in June 2024 and ending in March 2025. This option includes a 6% service fee, reflected in the numbers above.

Should the Enrollment Contract be entered into subsequent to any of the applicable foregoing dates, then amounts stated for the respective date(s) shall be due immediately upon signing of the Enrollment Contract.

FCM FA: The FCM Family Association is responsible for organizing events throughout the year that bring the community together and for organizing volunteer activities at FCM. The following fees are collected in order to facilitate these events and activities.

- **FCMFA Family Fee: \$50** - An annual fee per family that funds FCM community events.
- **FCMFA Classroom Fund: \$25 per child** - These funds are used for classroom projects, gifts for teachers and staff, and/or classroom gifts.

Field Trip Fees: Extended Day and Elementary students take various field trips (museums, music performances, campouts, and other opportunities). Third-Year Lower Elementary students also travel to Washington, DC. UE families, please refer to the UE Tuition Addendum regarding the cost of the Upper Elementary "Big Trip".

Field Trip Fees and FCM FA Fees are due in June 2024 unless otherwise specified.
